# Meitheal Sustainability Policy

## 2024 - 2026

At Fáilte Ireland, we recognise that the future of Ireland's tourism sector depends on our collective commitment to sustainability. As custodians of the environment and stewards of Ireland's global reputation as a leading destination for Business Events, we are taking proactive steps to embed sustainable practices into each event that is hosted in Ireland.

Meitheal is the largest and most important trade event in Ireland for the Irish tourism industry. The two day face-to-face event is hosted by Fáilte Ireland in collaboration with Tourism Ireland. It provides the Irish tourism industry a platform to sell the best of Ireland to overseas tourism buyers from more than 20 countries, with over 10,000 appointments conducted over the course of the event.

By adopting a 'Sustainability Policy' for Meitheal, Fáilte Ireland's flagship global trade fair, we aim to lead by example and support event organisers, venues, and suppliers in creating events that minimise the environmental footprint while maximising the positive handprint. The latter entails increasing the positive contributions towards sustainability and well-being.

This policy is applied on a phased approach from 2024-2026, implementing our key learnings from 2024 with the aim to progressively improve on our annual benchmarks.



# Strategic 'Sustainability Policy' for Meitheal

To quote the Department of Enterprise, Tourism and Employment, business events strategy, *Business Events 2030*:

*“By focusing on the economic, social and environmental pillars of sustainability, Ireland can strategically position itself as a leader in hosting business events.”*



With Ireland's five business event hubs (Dublin, Cork, Kerry, Galway, The Shannon Region), ranked among the top twenty on the Global Destination Sustainability Index, Ireland is a recognised leader in the delivery of sustainable business events. Fáilte Ireland's 'Meitheal Sustainability Policy' underscores the importance of embedding sustainable practices into each stage of the planning process, aligning with Ireland's business events strategy, *Business Events 2030*, and "A New Era for Irish Tourism", the National Tourism Policy Statement.

Fáilte Ireland is committed to incorporating Economic, Social and Governance (ESG) criteria into our procurement processes. In addition, waste reduction measures, green certifications and community partnerships are examples of initiatives that enable the creation of events that leave a lasting positive legacy. Our ambition for Meitheal is that it will become the most sustainable business event of its kind in Ireland over the course of the following years.

Together, we can ensure that Ireland remains not just a destination of choice, but a destination for conscientious behaviour in business events worldwide.

### 12 RESPONSIBLE CONSUMPTION AND PRODUCT

Support business events in Ireland through various initiatives aimed at promoting sustainable practices in event planning, execution, and management. These events often emphasise reducing waste, conserving resources, and adopting eco-friendly alternatives.
